### **Investment Objective and Strategy**

The fundamental investment objective of the First Trust ETF is to provide unitholders with a high level of current income by investing primarily in a diversified portfolio of senior floating rate loans and debt securities, with capital appreciation as a secondary objective. The First Trust ETF will primarily invest in a portfolio of senior floating rate loans which are generally rated at or below BB+ by Standard & Poor's, or Ba1 or less by Moody's Investor Services, Inc., or a similar rating by designated credit rating organization (as defined in NI 81- 102) and debt securities by holding securities of First Trust Senior Loan Fund, a U.S. listed exchange-traded fund (the "Underlying Fund"). The First Trust ETF will generally seek to hedge substantially all of its U.S. dollar currency exposure back to the Canadian dollar.

The primary investment objective of the Underlying Fund is to provide high current income and its secondary investment objective is preservation of capital. The Underlying Fund seeks to achieve its investment objectives by investing in a portfolio of senior floating rate loans which are generally rated at or below BB+ by Standard & Poor's, or Ba1 or less by Moody's Investor Services, Inc., or a similar rating by a designated rating organization (as defined in NI 81-102) and debt securities.

#### Risk

The overall risk for the First Trust ETF during the period remains as discussed in the most recent prospectus for the First Trust ETF.

The ability of a company/issuer to pay interest and repay principal are not factors controlled by the First Trust ETF's management. A company may default on their obligation to repay interest and principal which could impact the value of the holdings in the First Trust ETF or the ability to pay a dividend at or above the current level. Companies may also refinance their existing debt (the First Trust ETF's holdings) which would also impact the level of income available to pay to shareholders.

The First Trust ETF is suitable for investors seeking a high level of current income and potential for capital gains through exposure to a diversified portfolio of below investment grade debt securities.

#### **Results of Operations**

#### General

The First Trust ETF's total net asset value as of June 30, 2023 was \$36,101,194 or \$16.88 per unit. The First Trust ETF's total net asset value as of December 31, 2022 was \$37,139,987 or \$16.59 per unit.

For the six-month period ended June 30, 2023, the First Trust ETF paid total cash distributions of \$0.6050 per unit. In addition, the First Trust ETF declared cash distributions of \$0.1350 per unit for record date of June 30, 2023 with payment date of July 10, 2023.

The First Trust ETF's only holding, the Underlying Fund, held 177 individual positions (0.56% average position size) diversified across 32 industries at the end of the reporting period. The top ten holdings by issuer accounted for 34% of the portfolio. Software (19.53%), Insurance (13.66%), and Healthcare Technology (13.02%) comprised the top three industries by market value at the end of the period.

#### **Investment Performance**

For the six-month period ended June 30, 2023, the First Trust ETF returned 5.83% compared to the Morningstar® LSTA® US Leveraged Loan Index CAD-Hedged ("benchmark") return of 6.16%. Unlike the benchmark, the First Trust ETF's returns are net of fees and expenses.

The First Trust ETF's only holding, the Underlying Fund, maintained its defensive positioning in high quality companies with strong balance sheets and robust cash flow. Throughout the period, the investment team increased the Underlying Fund's exposure to BBB and BB rated credit to reduce overall portfolio volatility and enhance liquidity.

As of June 30, 2023, the Underlying Fund maintained allocations to BBB rated, BB rated, B rated, and CCC and below rated assets (including Not Rated) of 13.95%, 18.15%, 61.55%, and 6.34%, respectively.

Throughout the reporting period, the Underlying Fund benefitted from strong security selection within both the Capital Markets industry as well as the IT Services industry. Within the Capital Markets industry, the Underlying Fund's overweight allocation to a financial advisory services company proved a tailwind to performance. Additionally, within the IT Services sector, the Underlying Fund's overweight allocation to a healthcare technology company served as the largest contributor to performance. The Underlying Fund's overweight allocation and security selection within the Media industry proved a headwind to performance. Further, within the Commercial Services & Supplies sector, the Underlying Fund's position in a business services company that experienced the loss of a large customer contract also detracted from performance. From an asset allocation perspective, the Underlying Fund positioned in high quality bonds and cash to reduce overall volatility. We expect this defensive positioning to serve the Underlying Fund well over time.

The Leveraged Finance Investment Team's investment process combines rigorous bottom-up fundamental credit analysis and disciplined portfolio construction. The First Trust ETF experienced zero defaults throughout the period, while the Morningstar® LSTA® US Leveraged Loan Index ("LLI") experienced 16 defaults. Since inception, the First Trust ETF has experienced ten defaults; this compares favorably to the 166 defaults experienced by the LLI over that same time period.

#### **Recent Developments**

The senior loan market experienced six consecutive monthly outflows throughout the period, marking \$18.5bn in outflows over the last 6 months. Despite such outflows, senior loan spreads tightened 93 basis points ("bps") to end the period at L+552. The current spread is 35 bps above the senior loan market's long-term average spread of L+517, dating back to December 1997.

As we enter the third quarter, we expect the Fed to "leak" additional rate hikes into the market, albeit at a slower pace, and to hold rates higher until they are confident that they have either (1) achieved their 2.00% inflation target, or (2) sufficiently weakened the labor market to the point of recession. Given our expectation of a recession in late 2023 or early 2024, we continue to focus on high-quality companies in defensive sectors. As we assess such market opportunities, we continue to employ our disciplined bottom-up credit underwriting process and rigorous approach to risk management.

### **Related Party Transactions**

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

#### **Management Fees**

The First Trust ETF will pay the Manager a management fee of 0.15% based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

The First Trust ETF will bear the Underlying Fund's management fee of 0.85% per annum on average daily net assets on the First Trust ETF's portfolio assets invested in the Underlying Fund. Accordingly, the management fee cost to unitholders of their investment will be 1.00% per annum of NAV of the First Trust ETF plus applicable taxes.

<sup>(3)</sup> The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the period/year. The higher a First Trust ETF's portfolio turnover rate in a period/year, the greater the trading cost payable by the First Trust ETF in the period/year, and the greater the chance of an investor receiving taxable capital gains in the period/year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.


#### **Past Performance**
