Investment Objective and Strategy

The fundamental investment objective of **First Trust Tactical Bond Index ETF** (the "First Trust ETF") is to replicate, to the extent possible, the performance of the NASDAQ Canadian Preservation CAD TRSM (the "Index"), net of expenses.

The investment strategy of the First Trust ETF is to invest in and hold the constituent securities of the Index in the same proportion as they are reflected in the Index or securities intended to replicate the performance of such Index. The First Trust ETF may also hold cash and cash equivalents or other money market instruments to fund current liabilities.

The Index seeks to construct a dynamic fixed income portfolio that provides exposure to several different fixed income asset classes and consists of ETFs.

The Manager may use a sampling methodology in selecting investments for the First Trust ETF. As an alternative or in conjunction with investing in and holding constituent securities, the First Trust ETF may also invest in other securities to obtain exposure to the constituent securities of the applicable Index in a manner that is consistent with the investment objective and investment strategy of the First Trust ETF.

Risk

The risks associated with an investment in the First Trust ETF remain as discussed in the First Trust ETF's most recent prospectus. There have been no significant changes during the period that affected the overall level of risk associated with the First Trust ETF.

Results of Operations

General

The First Trust ETF's net asset value as of June 30, 2020 was \$5,608,831 or \$16.03 per unit. The First Trust ETF's net asset value as of December 31, 2019 was \$10,972,765 or \$18.29 per unit.

For the six-month period ended June 30, 2020, the First Trust ETF paid total cash distributions per unit of \$0.3000. In addition, the First Trust ETF declared cash distributions per unit of \$0.0500 for record date of June 30, 2020 with payment date of July 8, 2020.

Investment Performance

For the six-month period ended June 30, 2020, the First Trust ETF returned -10.78% compared to the Index return of -10.59%. Unlike the Index, the First Trust ETF's return is net of fees and expenses.

Most of the underperformance happened in the first quarter of the year, with March the most severe month. The return for the First Trust ETF in the first quarter of 2020 was -13.60%, while the return for the Index was -13.49%. Performance improved for the First Trust ETF and the Index in the second quarter of 2020, with First Trust ETF returning 3.27% and the Index returning 3.35%.

When looking into the index details, we found that the Index performance was mainly hurt by its High-Yield exposures. The Index held two High-Yield ETFs; iShares Convertible Bond Index ETF (CVD.TO) and iShares U.S. High Yield Bond Index ETF (CAD-Hedged) (XHY.TO), dating back to the start of the year.

The Index deploys a proprietary quantitative model that has the flexibility to decrease or increase duration and credit risk via a momentum-driven, tactical overlay. The current index positions, as suggested by the model, favor investment-grade, intermediate-maturity, Canadian-based bonds.

Recent Developments

The COVID-19 global pandemic is still a developing story. Fortunately, The United States Federal Reserve, among all other major central banks, has promptly responded with sufficient liquidities, a.k.a. the "QE3", to bail out the global economy. Among all those measures, the Primary Market Corporate Credit Facility for new bond and loan issuance and the Secondary Market Corporate Credit Facility for liquidity support of outstanding corporate bonds will provide the most needed protections for credit market investors. The credit markets, both investment grade and high yield, have largely recovered from the initial shock and liquidity freeze. No matter which letter the chart of the shape of the recovery path will look like; V, U, L or W, the market is seeing continuous optimism for the higher yield credit products. Given that the Index has High-Yield exposure in its selection pool, we may gradually pick up on more High-Yield sectors with the market risk appetite coming back.

Related Party Transactions

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

⁽²⁾ Net asset value and distributions are based on the actual number of units outstanding at the relevant time. The increase/decrease from operations is based on the weighted average number of units outstanding over the period/year.

⁽³⁾ Distributions were paid in cash or reinvested in additional units of the First Trust ETF, or both. Non-cash distributions are reinvested in additional units of the First Trust ETF and subsequently consolidated. Neither the number of units held by the unitholder, nor the net asset per unit of the First Trust ETF change as a result of any non-cash distributions.

⁽⁴⁾ This table is not intended to be a reconciliation of beginning to ending net asset value per unit.

⁽²⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period/year. This includes the First Trust ETF's proportionate share of the commissions of any underlying fund in which the First Trust ETF has invested.

⁽³⁾ The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the period/year. The higher a First Trust ETF's portfolio turnover rate in a period/year, the greater the trading cost payable by the First Trust ETF in the period/year, and the greater the chance of an investor receiving taxable capital gains in the period/year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.

Management Fees

The First Trust ETF will pay the Manager a management fee of 0.50% based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.


Past Performance

General
