#### **Investment Objective and Strategy**

The fundamental investment objective of **First Trust Cloud Computing ETF** (the "First Trust ETF") is to replicate, to the extent possible, the performance of an index of U.S. companies involved in the cloud computing industry, initially the ISE CTA Cloud Computing<sup>™</sup> Index.

The ISE CTA Cloud Computing<sup>™</sup> Index is a modified equal weighted index designed to track the performance of companies involved in the cloud computing industry. To be included in the index, a security must be classified as a Cloud Computing company by the Consumer Technology Association.

#### Risk

The First Trust ETF provides exposure to its index by investing all or substantially all of its assets in an underlying U.S. index fund known as First Trust Cloud Computing ETF (the "Underlying Fund"), which is managed by the First Trust ETF's portfolio advisor.

The risks associated with an investment in the First Trust ETF is discussed in the First Trust ETF's most recent prospectus.

#### **Results of Operations**

#### General

The First Trust ETF's net asset value as of December 31, 2024, was \$8,729,407 or \$30.10 per unit. The First Trust ETF's net asset value as of December 31, 2023, was \$2,659,375 or \$20.46 per unit.

There were no cash distributions paid nor declared for the year ended December 31, 2024.

#### Investment Performance

For the year ended December 31, 2024, the First Trust ETF returned 47.15% compared to the S&P 500® Index (the "benchmark") return of 36.36%. Unlike the benchmark, the First Trust ETF's return is net of fees and expenses.

The First Trust ETF's only holding, the Underlying Fund, held 61 equity securities as of December 31, 2024. The top ten equity holdings for the Underlying Fund accounted for 38.19% of the portfolio within the Underlying Fund.

The Underlying Fund outperformed the benchmark during the year due to an overweight position in the Information Technology sector. Notably, an overweight position in AppLovin Corporation contributed significantly to the outperformance. No weight in NVIDIA Corporation partially offset the outperformance.

The Underlying Fund's top five stocks by contribution to return were AppLovin Corporation, Arista Networks Inc, Pure Storage, Inc., Lumen Technologies, Inc., and Oracle Corporation. The Underlying Fund's bottom five stocks by contribution to return were MongoDB, Inc., Fastly, Inc., Five9, Inc., Akamai Technologies, Inc., and Adobe Inc.

The First Trust's ETF's exposure to the U.S. dollar contributed positively to its absolute performance during the year, as the U.S. dollar appreciated 8.96% against the Canadian dollar from December 29, 2023, to December 31, 2024.

#### **Recent Developments**

Despite having been around for 20 years, give or take, there continue to be new applications and end markets for cloud technology. Gartner, a leading technology research and consulting firm, forecasts a 21.4% growth in year-over-year cloud spending for 2025 and has written the following regarding corporate capital expenditures as a whole, "Software leads spending growth categories." Complementary to both artificial intelligence ("Al") and quantum computing, the need to run and host cloud applications is amplified by the increased use of compute-intensive Al/quantum. Another trend that was big in 2024 and that is expected to continue growing into 2025 is multi-cloud, the practice of using two or three cloud providers to leverage particular areas of expertise and increase security. In summary, the momentum of cloud in 2024 is expected to carry over into 2025 and shows no signs of wavering.

#### **Related Party Transactions**

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

<sup>(2)</sup> The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the year. This includes the First Trust ETF's proportionate share of the commissions of Underlying Fund in which the First Trust ETF has invested.

<sup>(3)</sup> The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the year. The higher a First Trust ETF's portfolio turnover rate in a year, the greater the trading cost payable by the First Trust ETF in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.

#### Management Fees

The First Trust ETF will pay the Manager a management fee of 0.15% based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

The First Trust ETF's management fee will also bear the management fee of the Underlying Fund.


#### **Past Performance**

#### General

The past performance information shown assumes that all distributions made by the First Trust ETF in the years shown were reinvested in additional securities of the First Trust ETF. #### Year by Year Returns
