## First Trust Global Risk Managed Income Index ETF (the "First Trust ETF")

This annual management report of fund performance contains financial highlights, but does not contain the complete audited annual financial statements of the First Trust ETF. All references to dollars contained herein are to Canadian dollars.

### **Investment Objective and Strategy**

The fundamental investment objective of **First Trust Global Risk Managed Income Index ETF** (the "First Trust ETF") is to replicate, to the extent possible, the performance of the NASDAQ Global Risk Managed Income Index<sup>SM</sup> (the "Index"), net of expenses.

The investment strategy of the First Trust ETF is to invest in and hold the constituent securities of the Index in the same proportion as they are reflected in the Index or securities intended to replicate the performance of such Index. The First Trust ETF may also hold cash and cash equivalents or other money market instruments to fund current liabilities.

The Index seeks to provide exposure to a risk managed, global income portfolio which generates a high yield for the risk taken and consists of liquid income-bearing ETFs and other exchange traded products across various asset classes.

The Manager may use a sampling methodology in selecting investments for the First Trust ETF. As an alternative or in conjunction with investing in and holding constituent securities, the First Trust ETF may also invest in other securities to obtain exposure to the constituent securities of the applicable Index in a manner that is consistent with the investment objective and investment strategy of the First Trust ETF.

### Risk

The risks associated with an investment in the First Trust ETF remain as discussed in the First Trust ETF's most recent prospectus. There have been no significant changes during the period that affected the overall level of risk associated with the First Trust ETF.

### **Results of Operations**

### General

The First Trust ETF's total net asset value as of December 31, 2020 was \$23,726,014 or \$18.24 per Common Class unit ("ETP") and \$18.40 per Advisor Class unit ("ETP.A"). The First Trust ETF's total net asset value as of December 31, 2019 was \$28,676,169 or \$19.11 per ETP and \$19.24 per ETP.A.

For the year ended December 31, 2020, the First Trust ETF paid total cash distributions per unit of \$0.6950 for ETP and \$0.5750 for ETP.A. In addition, the First Trust ETF declared cash distributions per unit of \$0.0550 for ETP and \$0.0450 for ETP.A for record date of December 31, 2020 with payment date of January 8, 2021.

#### Investment Performance

For the year ended December 31, 2020, ETP returned -0.72% and ETP.A returned -1.25% compared to the Index return of -0.25%. Unlike the Index, the First Trust ETF's returns are net of fees and expenses.

Most of the underperformance happened in the first quarter of the year, when the pandemic had just broken out, with March the most severe month. The return for ETP in the first quarter of 2020 was -14.76%, the return for ETP.A was -14.88%, and the return for the Index was -14.64%. The Index actually performed well in the remaining three quarters of 2020, during which the world continuously fought the virus and as investors' appetite for investing in the financial markets gradually came back.

The global outbreak of the COVID-19 pandemic and the sudden freezing of market liquidity in March didn't favor the First Trust ETF or the Index, which has Higher Yield and Higher Risk as a result of its blended equity and high yield credit positions.

The Index and its weightings are calculated using Newfound's proprietary, dynamic and volatility-adjusted momentum model to allocate more weights to index securities with a higher yield-to-risk profile and positive price momentum. Based on the model, the current weightings, as measured by the December 31<sup>st</sup> portfolio weights, is very similar to its allocation in June. Overall, when comparing to weights at the beginning of the year, The Index has increased 7% in allocation to fixed income relative to equity, mostly in Emerging market and Canadian based High Yield such as preferred shares and convertible bonds.

### **Recent Developments**

At least three COVID-19 vaccines have been approved and available to the public in the western world. But the pandemic will not end overnight. Lancet still predicts that "it will likely be a few years before the virus can be brought under control worldwide". The deferred schedule of establishing herd immunity might mean that financial markets will still face great uncertainty in 2021.

Democrats' success in both the U.S. presidential and congressional elections could also trigger dramatic political and economic policy changes, which decrease the chances of a common market outlook that investment professionals agree upon. Perhaps the preferred way to succeed in 2021 is to stay nimble and balanced. The Index's proprietary approach of tactically allocating funds between equities, high yields and/or safe haven assets could well suit investors navigating through the transitory year of 2021.

### **Related Party Transactions**

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

(1) Management expense ratio is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated year, including the First Trust ETF's proportionate share of the MER of any underlying fund in which the First Trust ETF has invested, and is expressed as an annualized percentage of daily average net asset value during the year.

(2) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the year. This includes the First Trust ETF's proportionate share of the commissions of any underlying fund in which the First Trust ETF has invested.

(3) The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the year. The higher a First Trust ETF's portfolio turnover rate in a year, the greater the trading cost payable by the First Trust ETF in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.

### Management Fees

The First Trust ETF will pay the Manager a management fee of 0.60% and, in respect of the ETP.A, an additional amount for a service fee (see "ETP.A Service Fee" below) based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

The First Trust ETF currently pays the Manager a management fee equal to 0.41%.

### ETP.A Service Fee

The Manager pays registered dealers a service fee equal to 0.50% per annum of the NAV of the Units held by clients of the registered dealer, plus any applicable taxes. The service fee will be calculated and accrued daily and paid quarterly at the end of each calendar quarter.


### Past Performance

### General

The past performance information shown assumes that all distributions made by the First Trust ETF in the period/years shown were reinvested in additional securities of the First Trust ETF. The performance information does not take into account sales, redemption, distribution or other optional charges that would have reduced returns or performance.
