Investment Objective and Strategy

The fundamental investment objective of **First Trust AlphaDEX™ U.S. Industrials Sector Index ETF** (the “First Trust ETF”) is to replicate, to the extent possible, the performance of the StrataQuant® Industrials Index (“Index”), net of expenses.

The investment strategy of the First Trust ETF is to invest in and hold the constituent securities of the Index in the same proportion as they are reflected in the Index or securities intended to replicate the performance of such Index. The Index results from applying the AlphaDEX™ methodology to the Russell 1000® Index, a market index representing the large and mid-capitalization segment of the U.S. equity universe, and then selecting the constituent securities for the Index from those qualifying stocks included in the Industrials/Producer Durables Sector.

The Manager may use a sampling methodology in selecting investments for the First Trust ETF. As an alternative or in conjunction with investing in and holding constituent securities, the First Trust ETF may also invest in other securities to obtain exposure to the constituent securities of the applicable Index in a manner that is consistent with the investment objective and investment strategy of the First Trust ETF.

In this case, the First Trust ETF may also obtain exposure to the applicable Index by holding securities of a US-listed index ETF, First Trust Industrials/Producer Durables AlphaDEX® Fund (NYSE Arca ticker: FXR), of an affiliate of the Manager, which replicates or substantially replicates the applicable Index.

Risk

The risks associated with an investment in the First Trust ETF remain as discussed in the First Trust ETF’s most recent prospectus. There have been no significant changes during the reporting period that affected the overall level of risk associated with the First Trust ETF. The First Trust ETF provides exposure to the industrials sector of the U.S. equity market in either a non-U.S. currency hedged and U.S. currency hedged manner.

Results of Operations

General

The First Trust ETF’s total net asset value as of June 30, 2023 was \$20,382,311 or \$42.22 per Unit (“FHG”) and \$27.68 per Hedged Unit (“FHG.F”). The First Trust ETF’s total net asset value as of December 31, 2022 was \$23,962,727 or \$37.06 per Unit (“FHG”) and \$23.85 per Hedged Unit (“FHG.F”).

For the six-month period ended June 30, 2023, the First Trust ETF paid total cash distributions per unit of \$0.3806 for FHG and \$0.1831 for FHG.F. In addition, the First Trust ETF declared cash distributions per unit of \$0.0500 for FHG and \$0.0350 for FHG.F for record date of June 30, 2023 with payment date of July 10, 2023.

Investment Performance

For the six-month period ended June 30, 2023, FHG returned 14.19% compared to the Russell 1000® Industrials Index (CAD) (the “benchmark”) total return of 8.15% while FHG.F returned 16.36% compared to the Russell 1000® Industrials Index (USD) (the “hedged benchmark”) total return of 10.74%. Unlike the benchmark and the hedged benchmark, the First Trust ETF’s returns are net of fees and expenses.

As of June 30, 2023, the Industrials sector accounted for 12.82% of the weight of the Russell 1000® Index. The benchmark underperformed the Russell 1000® Index (CAD) which returned 13.95%. The hedged benchmark underperformed the Russell 1000® Index (USD) which returned 16.68%.

As of June 30, 2023, the portfolio held 129 equity securities. The top ten equity holdings accounted for 15.59% of the total NAV. The AlphaDEX™ stock selection process is a rules-based process and can result in industry weightings that differ from that of the benchmark and the hedged benchmark.

The First Trust ETF outperformed the benchmark and the hedged benchmark during the period. An overweight allocation to Construction and Materials drove the outperformance. Stock selection within General Industrials dampened the outperformance.

The U.S. dollar depreciated 2.22% against the Canadian dollar from December 31, 2022, to June 30, 2023. FHG.F hedges its exposure to the U.S. dollar.

The top five stocks by contribution to return were Builders FirstSource, Inc., TopBuild Corp., Owens Corning, Vontier Corporation, and Core & Main, Inc. The bottom five stocks by contribution to return were WestRock Company, Valmont Industries, Inc., ADT Inc., 3M Company and Spirit AeroSystems Holdings, Inc.

Recent Developments

The Russell 1000® Index rebounded in the first half of 2023, gaining 16.68%, including dividends. The U.S. dollar depreciated relative to the Canadian dollar, meaning the index gained 13.95% over the same period measured in Canadian dollars. However, the gains were concentrated in a few mega-cap companies from the Information Technology, Communication Services, and Consumer Discretionary sectors that rebounded from last year's losses as 2022's bearish sentiment subsided. These three sectors were the best-performing sectors in the first half of 2023. Consumer Discretionary stocks, in particular, benefitted from announcing better-than-expected earnings during the period. Energy, Utilities, and Health Care were the three worst-performing sectors. Utilities stocks as a group missed earnings expectations during the period. Inflation continued to taper off during the period, reaching its lowest level since early 2021 of 3.00% by June, largely driven by decreased energy prices. The U.S. Federal Reserve paused its rate-hike campaign at its June meeting but signaled that further interest rate hikes would be needed to bring down inflation. With the process of bringing inflation down to the Fed's 2.00% target playing out more slowly than expected, the market mostly abandoned its expectation of rate cuts later this year, a significant development in the first half of 2023. Despite the Fed's aggressive interest rate hikes, the U.S. economy so far has avoided a much-anticipated recession. The economy expanded in the first quarter, albeit slower than in 2022's fourth quarter. Overall, the U.S. 10-year Treasury yield decreased slightly from 3.87% at the start of the period to 3.84% at the end of the period, while shorter-term rates increased significantly. Overall, the Russell 1000® Index finished the first half trading at a 20.1 P/E multiple with a 1.53% dividend yield, more expensive than 17.4 and 1.74%, respectively, at the end of 2022.

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

(2) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period/year.

(3) The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the period/year. The higher a First Trust ETF's portfolio turnover rate in a period/year, the greater the trading cost payable by the First Trust ETF in the period/year, and the greater the chance of an investor receiving taxable capital gains in the period/year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.

Management Fees

The First Trust ETF will pay the Manager a management fee of 0.70% based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

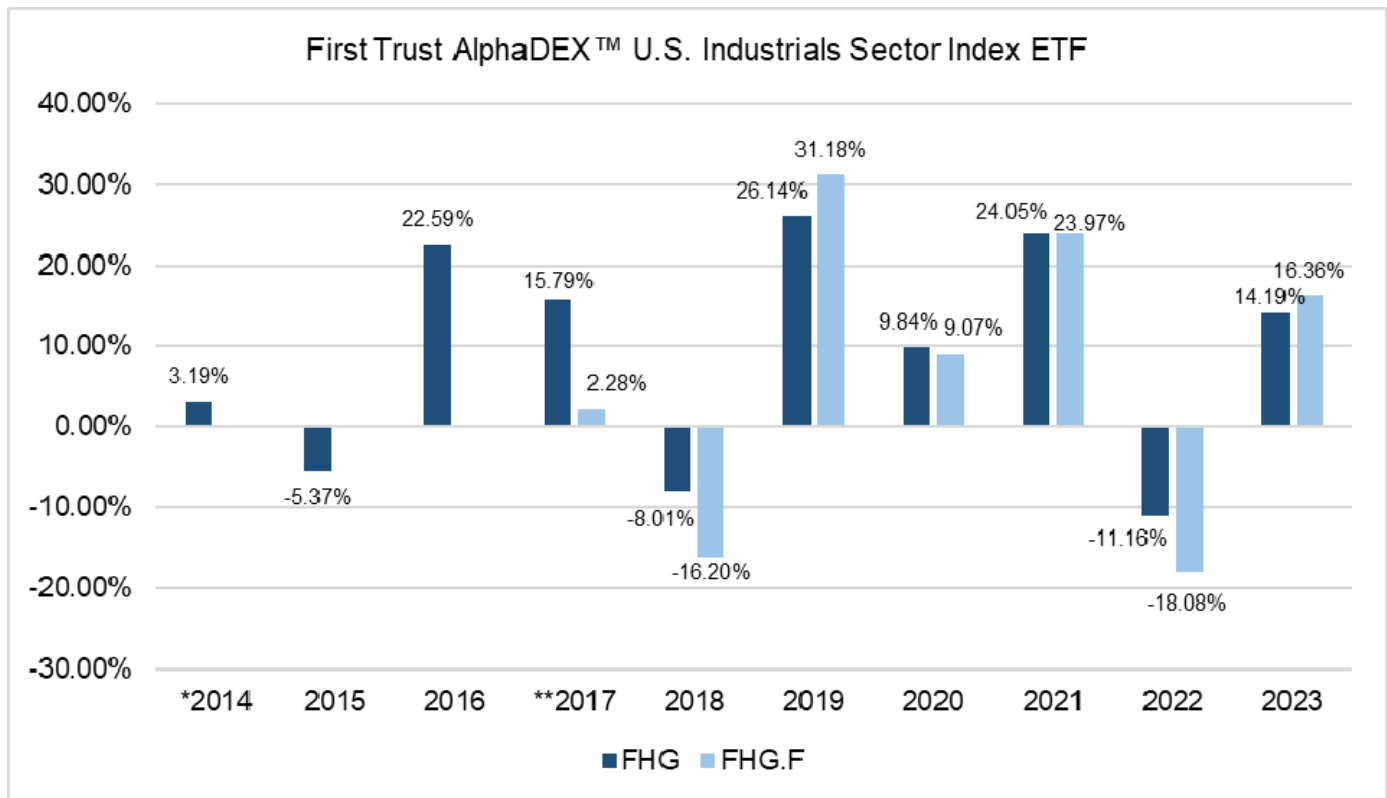
Past Performance
