First Trust AlphaDEX[™] U.S. Industrials Sector Index ETF (the "First Trust ETF")

Investment Objective and Strategy

The fundamental investment objective of **First Trust AlphaDEX™ U.S. Industrials Sector Index ETF** (the "First Trust ETF") is to replicate, to the extent possible, the performance of the StrataQuant® Industrials Index ("Index"), net of expenses.

The investment strategy of the First Trust ETF is to invest in and hold the constituent securities of the Index in the same proportion as they are reflected in the Index or securities intended to replicate the performance of such Index. The Index results from applying the AlphaDEX[™] methodology to the Russell 1000® Index, a market index representing the large and mid-capitalization segment of the U.S. equity universe, and then selecting the constituent securities for the Index from those qualifying stocks included in the Industrials/Producer Durables Sector.

The Manager may use a sampling methodology in selecting investments for the First Trust ETF. As an alternative or in conjunction with investing in and holding constituent securities, the First Trust ETF may also invest in other securities to obtain exposure to the constituent securities of the applicable Index in a manner that is consistent with the investment objective and investment strategy of the First Trust ETF.

In this case, the First Trust ETF may also obtain exposure to the applicable Index by holding securities of a US-listed index ETF, First Trust Industrials/Producer Durables AlphaDEX® Fund (NYSE Arca ticker: FXR), of an affiliate of the Manager, which replicates or substantially replicates the applicable Index.

Risk

The risks associated with an investment in the First Trust ETF remain as discussed in the First Trust ETF's most recent prospectus. There have been no significant changes during the reporting period that affected the overall level of risk associated with the First Trust ETF. The First Trust ETF provides exposure to the industrials sector of the U.S. equity market in either a non-U.S. currency hedged and U.S. currency hedged manner.

Results of Operations

General

The First Trust ETF's total net asset value as of December 31, 2021 was \$50,933,664 or \$42.29 per Unit ("FHG") and \$29.42 per Hedged Unit ("FHG.F"). The First Trust ETF's total net asset value as of December 31, 2020 was \$16,074,682 or \$34.22 per FHG and \$23.87 per FHG.F.

For the year ended December 31, 2021, the First Trust ETF paid total cash distributions per unit of \$0.2555 for FHG and \$0.2790 for FHG.F. In addition, the First Trust ETF declared cash distributions per unit of \$0.0444 for FHG and \$0.0947 for FHG.F for record date of December 31, 2021 with payment date of January 10, 2022. The First Trust ETF also made total notional distributions per unit of \$1.9470 for FHG and \$2.3784 for FHG.F for the year ended December 31, 2021. These amounts were reinvested in the First Trust ETF and not paid in cash to unitholders.

Investment Performance

For the year ended December 31, 2021, FHG returned 24.05% compared to the Russell 1000® Industrials Index (CAD) (the "benchmark") total return of 15.13% while FHG.F returned 23.97% compared to the Russell 1000® Industrials Index (USD) (the "hedged benchmark") total return of 16.12%. Unlike the benchmark and the hedged benchmark, the First Trust ETF's returns are net of fees and expenses.

As of December 31, 2021, the Industrials sector accounted for 12.79% of the weight of the Russell 1000® Index. The benchmark underperformed the Russell 1000® Index (CAD) which returned 25.38%. The hedged benchmark underperformed the Russell 1000® Index (USD) which returned 26.45%.

The portfolio held 132 equity securities as of December 31, 2021. The top ten equity holdings accounted for 14.34% of the portfolio. The AlphaDEX[™] stock selection process is a rules-based process and can result in industry weightings that differ from that of the benchmark and the hedged benchmark.

The First Trust ETF outperformed the benchmark and the hedged benchmark during the period. The First Trust ETF benefited from the underweight position in Industrial Support Services as well as strong stock selection within the industry. Construction and Materials was also a significant positive contributor to the First Trust ETF's performance due to its overweight position and strong stock selection within the industry. Finally, strong stock selection within the General Industrial industry also furthered the First Trust ETF's outperformance.

The U.S. dollar depreciated 0.93% against the Canadian dollar from December 31, 2020, to December 31, 2021. FHG.F hedges its exposure to the U.S. dollar.

The top five stocks by contribution to return were Builders FirstSource, Inc., Bill.com Holdings, Inc., Generac Holdings Inc., Acuity Brands, Inc., Robert Half International Inc. The bottom five stocks by contribution to return were StoneCo Ltd. Class A, Paylocity Holding Corp., Virgin Galactic Holdings Inc, Allison Transmission Holdings, Inc., Shift4 Payments, Inc. Class A.

Recent Developments

The Russell 1000® Index gained 26.45% in 2021, including dividends, closing the period near its record high as the U.S. economy continued to recover from the COVID-19 pandemic. However, the U.S dollar depreciated relative to the Canadian dollar, meaning the index gained 25.38% over the same period measured in Canadian dollars. The U.S. unemployment rate improved throughout the year, dropping from 6.7% at the beginning of the period to 5.9% in June and 3.9% in December. However, pandemic-related labor and supply shortages combined with high demand for goods and services produced a surge in inflation during the period. By year-end, the Consumer Price Index increased 7% compared to the prior year, which was its highest yearly increase since 1982. High inflation caused the U.S. Federal Reserve to pivot from its easy-money policies, signaling after its December meeting that it would raise interest rates in 2022. Despite high inflation, real economic output in the U.S. grew 4% through the first three quarters of the year, the latest available data. The economic reopening benefitted cyclical stocks like energy, real estate, and financial companies, which were the three best-performing sectors during the period. Information technology, with robust demand for the sector's products producing record earnings for the sector, was the fourth-best performing sector during the period. Conversely, defensive stocks like utilities and consumer staples were the two worst performing sectors during the period. The Russell 1000® Index finished 2021 trading at a 27.0 P/E multiple with a 1.25% dividend yield, compared to 32.3 and 1.50%, respectively, at the end of 2020.

Related Party Transactions

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

(3) The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the period/year. The higher a First Trust ETF's portfolio turnover rate in a period/year, the greater the trading cost payable by the First Trust ETF in the period/year, and the greater the chance of an investor receiving taxable capital gains in the period/year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.

Management Fees

The First Trust ETF will pay the Manager a management fee of 0.70% based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.


Past Performance

General
