# **Investment Objective and Strategy**

The fundamental investment objective of **First Trust AlphaDEX™ U.S. Health Care Sector Index ETF** (the "First Trust ETF") is to replicate, to the extent possible, the performance of the StrataQuant® Health Care Index ("Index"), net of expenses.

The investment strategy of the First Trust ETF is to invest in and hold the constituent securities of the Index in the same proportion as they are reflected in the Index or securities intended to replicate the performance of such Index. The Index results from applying the AlphaDEX<sup>™</sup> methodology to the Russell 1000® Index, a market index representing the large and mid-capitalization segment of the U.S. equity universe, and then selecting the constituent securities for the Index from those qualifying stocks included in the Health Care Sector.

The Manager may use a sampling methodology in selecting investments for the First Trust ETF. As an alternative or in conjunction with investing in and holding constituent securities, the First Trust ETF may also invest in other securities to obtain exposure to the constituent securities of the applicable Index in a manner that is consistent with the investment objective and investment strategy of the First Trust ETF.

In this case, the First Trust ETF may also obtain exposure to the applicable Index by holding securities of a US-listed index ETF, First Trust Health Care AlphaDEX® Fund (NYSE Arca ticker: FXH), of an affiliate of the Manager, which replicates or substantially replicates the applicable Index.

## Risk

The risks associated with an investment in the First Trust ETF remain as discussed in the First Trust ETF's most recent prospectus. There have been no significant changes during the reporting year that affected the overall level of risk associated with the First Trust ETF. The First Trust ETF provides exposure to the Health Care sector of the U.S. equity market in either a non-U.S. currency hedged and U.S. currency hedged manner.

# **Results of Operations**

## General

The First Trust ETF's total net asset value as of June 30, 2024, was \$12,430,805 or \$38.48 per Unit ("FHH") and \$28.10 per Hedged Unit ("FHH.F"). The First Trust ETF's total net asset value as of December 31, 2023, was \$13,868,347 or \$36.92 per FHH and \$27.92 per FHH.F.

For the six-month period ended June 30, 2024, the First Trust ETF paid total cash distributions per unit of \$0.0600 for FHH and \$0.0400 for FHH.F. In addition, the First Trust ETF declared cash distributions per unit of \$0.0300 for FHH and \$0.0200 for FHH.F for record date of June 28, 2024, with payment date of July 8, 2024.

## Investment Performance

For the six-month period ended June 30, 2024, FHH returned 4.39% compared to the Russell 1000® Health Care Index (CAD) (the "benchmark") total return of 11.93% while FHH.F returned 0.78% compared to the Russell 1000® Health Care Index (USD) (the "hedged benchmark") total return of 7.86%. Unlike the benchmark and the hedged benchmark, the First Trust ETF's returns are net of fees and expenses.

As of June 30, 2024, the Health Care sector accounted for 11.10% of the weight of the Russell 1000® Index. The benchmark underperformed the Russell 1000® Index (CAD), which returned 18.55%. The hedged benchmark underperformed the Russell 1000® Index (USD), which returned 14.24%.

As of June 30, 2024, the portfolio held 81 equity securities. The top ten equity holdings accounted for 25.59% of the total NAV. The AlphaDEX<sup>™</sup> stock selection process is a rules-based process and can result in industry weightings that differ from that of the benchmark and the hedged benchmark.

The First Trust ETF underperformed the benchmark during the period due to stock selection within the Medical Equipment and Services and Pharmaceuticals and Biotechnology sectors.

The U.S. dollar appreciated 3.54% against the Canadian dollar from December 31, 2023, to June 30, 2024. FHH.F hedges its exposure to the U.S. dollar.

The top five stocks by contribution to return were Natera, Inc., United Therapeutics Corporation, Eli Lilly and Company, Tenet Healthcare Corporation, and Medpace Holdings, Inc. The bottom five stocks by contribution to return were QuidelOrtho Corporation, 10x Genomics, Inc., Integra LifeSciences Holdings Corporation, Bristol-Myers Squibb Company, and Molina Healthcare, Inc.

## **Recent Developments**

The Russell 1000® Index returned 14.24%, including dividends, in the first half of the year. The U.S. dollar appreciated relative to the Canadian dollar, meaning the index gained 18.55% over the same period measured in Canadian dollars. The gains were concentrated in a few mega-cap companies from the Information Technology, Communication Services, and Consumer Discretionary sectors. NVIDIA, in particular, benefitted from booming demand for its artificial intelligence (AI) chips, which sent its market capitalization over \$3 trillion, joining Apple and Microsoft. As a result of the AI-driven rally, Information Technology and Communication Services were the best-performing sectors during the period. Materials and Real Estate, cyclical sectors that didn't benefit from the AI rally, were the period's two worst-performing sectors. Real Estate stocks also suffered from particular weakness in the US commercial real estate market. The overall market continued its ascent despite resilient inflation that stayed above 3% throughout the period. Given its resilience, the market continued to lower its expectations for Fed interest rate cuts this year. The market expected as many as six rate cuts to start the year, and halfway through, the Fed has yet to cut rates this year. Consequently, interest rates rose during the period. The 10-year Treasury yield finished the period at 4.40%, well above 3.88% where it began the year. Overall, the Russell 1000® Index finished the period trading at a 23.7 P/E multiple with a 1.32% dividend yield, more expensive than 21.7 and 1.46%, respectively, at the end of 2023.

#### **Related Party Transactions**

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

(3) The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the period/year. The higher a First Trust ETF's portfolio turnover rate in a period/year, the greater the trading cost payable by the First Trust ETF in the period/year, and the greater the chance of an investor receiving taxable capital gains in the period/year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.

## Management Fees

The First Trust ETF will pay the Manager a management fee of 0.70% based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.


# Past Performance

# General
