Investment Objective and Strategy

The fundamental investment objective of **First Trust AlphaDEX™ U.S. Health Care Sector Index ETF** (the “First Trust ETF”) is to replicate, to the extent possible, the performance of the StrataQuant® Health Care Index (“Index”), net of expenses.

The investment strategy of the First Trust ETF is to invest in and hold the constituent securities of the Index in the same proportion as they are reflected in the Index or securities intended to replicate the performance of such Index. The Index results from applying the AlphaDEX™ methodology to the Russell 1000® Index, a market index representing the large and mid-capitalization segment of the U.S. equity universe, and then selecting the constituent securities for the Index from those qualifying stocks included in the Health Care Sector.

The Manager may use a sampling methodology in selecting investments for the First Trust ETF. As an alternative or in conjunction with investing in and holding constituent securities, the First Trust ETF may also invest in other securities to obtain exposure to the constituent securities of the applicable Index in a manner that is consistent with the investment objective and investment strategy of the First Trust ETF.

In this case, the First Trust ETF may also obtain exposure to the applicable Index by holding securities of a US-listed index ETF, First Trust Health Care AlphaDEX® Fund (NYSE Arca ticker: FXH), of an affiliate of the Manager, which replicates or substantially replicates the applicable Index.

Risk

The risks associated with an investment in the First Trust ETF remain as discussed in the First Trust ETF’s most recent prospectus. There have been no significant changes during the reporting year that affected the overall level of risk associated with the First Trust ETF. The First Trust ETF provides exposure to the Health Care sector of the U.S. equity market in either a non-U.S. currency hedged and U.S. currency hedged manner.

Results of Operations

General

The First Trust ETF’s total net asset value as of December 31, 2025, was \$9,309,673 or \$42.12 per Unit (“FHH”) and \$29.92 per Hedged Unit (“FHH.F”). The First Trust ETF’s total net asset value as of December 31, 2024, was \$14,236,995 or \$40.27 per FHH and \$27.80 per FHH.F.

For the year ended December 31, 2025, the First Trust ETF paid total cash distributions per unit of \$0.0300 for FHH and \$0.0150 for FHH.F. In addition, the First Trust ETF declared cash distributions per unit of \$0.0200 for FHH and \$0.0100 for FHH.F for record date of December 31, 2025, with payment date of January 8, 2026. Lastly, the First Trust ETF also made notional distributions of \$2.1900 per unit for FHH and \$0.3500 per unit for FHH.F for the year ended December 31, 2025. These amounts were reinvested in the First Trust ETF and not paid in cash to unitholders.

Investment Performance

For the year ended December 31, 2025, FHH returned 4.72% compared to the Russell 1000® Health Care Index total return of 8.25% while FHH.F returned 7.74% compared to the Russell 1000® Health Care Index (USD) total return of 13.53%. Unlike the indices, the First Trust ETF’s returns are net of fees and expenses.

As of December 31, 2025, the Health Care sector accounted for 9.27% of the weight of the Russell 1000® Index. The Russell 1000® Health Care Index underperformed the Russell 1000® Index, which returned 11.86%. The Russell 1000® Health Care Index (USD) underperformed the Russell 1000® Index (USD), which returned 17.37%.

As of December 31, 2025, the portfolio held 76 equity securities. The top ten equity holdings accounted for 25.42% of the total NAV. The AlphaDEX™ stock selection process is a rules-based process and can result in industry weightings that differ from that of the indices.

The First Trust ETF underperformed the benchmark during the year due to sector allocation. An overweight position in Health Care Providers and an underweight position in Pharmaceuticals and Biotechnology weighed on relative performance. However, stock selection within the Health Care Providers sector mitigated the underperformance.

The U.S. dollar depreciated 4.65% against the Canadian dollar from December 31, 2024, to December 31, 2025. FHH.F hedges its exposure to the U.S. dollar.

The First Trust ETF's top five stocks by contribution to return were Elanco Animal Health Incorporated, Inmed Incorporated, Alnylam Pharmaceuticals, Inc., United Therapeutics Corporation, and Intra-Cellular Therapies, Inc. The First Trust ETF's bottom five stocks by contribution to return were Acadia Healthcare Company, Inc., Organon & Co., Molina Healthcare, Inc., Avantor, Inc., and Centene Corporation.

Recent Developments

U.S. stocks finished the year near all-time highs, lifted by earnings growth and optimism surrounding the development of artificial intelligence. The Russell 1000® Index returned 17.37% during the year, including dividends. However, the U.S. dollar depreciated relative to the Canadian dollar, meaning the index gained 11.86% over the same year measured in Canadian dollars. The year marked a volatile year for U.S. stocks, with stocks recovering from a significant drawdown in the first half of the year that culminated in April when the U.S. announced sweeping tariffs on its trading partners. However, the market reversed as tariff tensions eased. The artificial-intelligence trade, or AI trade, and development of adjacent technologies also propelled the rebound in large-cap stocks. Speculative stocks, or unprofitable companies, easily outperformed profitable companies, underscoring the market's optimism regarding AI's potential. The U.S. Federal Reserve cut interest rates three times during the year, citing a softening labor market, which also provided a tailwind for U.S. stocks. Overall, the Russell 1000® Index finished the year trading at a 25.2 P/E multiple with a 1.15% dividend yield, more expensive than where it stood at the end of 2024.

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

(2) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the year.

(3) The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the year. The higher a First Trust ETF's portfolio turnover rate in a year, the greater the trading cost payable by the First Trust ETF in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.

Management Fees

The First Trust ETF will pay the Manager a management fee of 0.70% based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.


Past Performance
