#### **Investment Objective and Strategy**

The fundamental investment objective of **First Trust Global Risk Managed Income Index ETF** (the “First Trust ETF”) is to replicate, to the extent possible, the performance of the NASDAQ Global Risk Managed Income Index<sup>SM</sup> (the “Index”), net of expenses.

The investment strategy of the First Trust ETF is to invest in and hold the constituent securities of the Index in the same proportion as they are reflected in the Index or securities intended to replicate the performance of such Index. The First Trust ETF may also hold cash and cash equivalents or other money market instruments to fund current liabilities.

The Index seeks to provide exposure to a risk managed, global income portfolio which generates a high yield for the risk taken and consists of liquid income-bearing ETFs and other exchange traded products across various asset classes.

The Manager may use a sampling methodology in selecting investments for the First Trust ETF. As an alternative or in conjunction with investing in and holding constituent securities, the First Trust ETF may also invest in other securities to obtain exposure to the constituent securities of the applicable Index in a manner that is consistent with the investment objective and investment strategy of the First Trust ETF.

#### **Risk**

The risks associated with an investment in the First Trust ETF remain as discussed in the First Trust ETF’s most recent prospectus. There have been no significant changes during the period that affected the overall level of risk associated with the First Trust ETF.

#### **Results of Operations**

##### **General**

The First Trust ETF’s total net asset value as of June 30, 2020 was \$23,180,812 or \$17.16 per Common Class unit (“ETP”) and \$17.30 per Advisor Class unit (“ETP.A”). The First Trust ETF’s total net asset value as of December 31, 2019 was \$28,676,169 or \$19.11 per ETP and \$19.24 per ETP.A.

For the six-month period ended June 30, 2020, the First Trust ETF paid total cash distributions per unit of \$0.3600 for ETP and \$0.3000 for ETP.A. In addition, the First Trust ETF declared cash distributions per unit of \$0.0600 for ETP and \$0.0500 for ETP.A for record date of June 30, 2020 with payment date of July 8, 2020.

##### **Investment Performance**

For the six-month period ended June 30, 2020, ETP returned -8.31% and ETP.A returned -8.55% compared to the Index return of -8.02%. Unlike the Index, the First Trust ETF’s returns are net of fees and expenses.

Most of the underperformance happened in the first quarter of the year, with March the most severe month. The return for ETP in the first quarter of 2020 was -14.76%, the return for ETP.A was -14.88%, and the return for the Index was -14.64%. Performance improved for ETP, ETP.A, and the Index in the second quarter of 2020, with ETP +7.57%, ETP.A +7.43%, and the Index +7.75%

The global outbreak of COVID-19 pandemic and the sudden freezing of market liquidity in March certainly un-favored the Index, which is a Higher-Yield, Higher-Risk portfolio, as a result of its blended equity and high yield credit positions.

The Index is evaluated by Newfound Research LLC's proprietary, dynamic and volatility-adjusted momentum model to allocate more weights to index securities with a higher yield-to-risk profile and positive price momentum. Based on the model, the current Index, as measured by the end of June portfolio weights, has moderately increased its holdings in Fixed Income assets across the credit spectrum, and mainly the emerging market CAD hedged bond ETF (BMO Emerging Market Bond Hedged to CAD Index ETF (ZEF.TO)). It currently has a 12.4% index weight, doubled from the beginning of the year weight of 6.2%.

**Recent Developments**

The COVID-19 global pandemic is still a developing story. There are many vastly different predictions and opinions on when the pandemic will end and how long until the world economy can fully recover. The embedded uncertainties among those discussions will inevitably and consistently be reflected in the financial markets and investors' portfolios in the remaining months of the year or, in the worst case, for many years. Meanwhile, nearly all central banks in the world's major economies have cut their benchmark interest rates to nearly zero, if not below. Investors seeking sufficient, stable income has become a more difficult job in these conditions. The Index's proprietary approach of tactically allocating funds to income bearing securities with favorable risk-adjusted return profiles should remain very attractive in this low- rate, high-volatility environment.

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

(1) Management expense ratio is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated period/year, including the First Trust ETF's proportionate share of the MER of any underlying fund in which the First Trust ETF has invested, and is expressed as an annualized percentage of daily average net asset value during the period/year.

(2) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period/year. This includes the First Trust ETF's proportionate share of the commissions of any underlying fund in which the First Trust ETF has invested.

(3) The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the period/year. The higher a First Trust ETF's portfolio turnover rate in a year, the greater the trading cost payable by the First Trust ETF in the period/year, and the greater the chance of an investor receiving taxable capital gains in the period/year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.

**Management Fees**

The First Trust ETF will pay the Manager a management fee of 0.60% and, in respect of the ETP.A, an additional amount for a service fee (see "ETP.A Service Fee" below) based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

The First Trust ETF currently pays the Manager a management fee equal to 0.41%.

**ETP.A Service Fee**

The Manager pays registered dealers a service fee equal to 0.50% per annum of the NAV of the Units held by clients of the registered dealer, plus any applicable taxes. The service fee will be calculated and accrued daily and paid quarterly at the end of each calendar quarter.

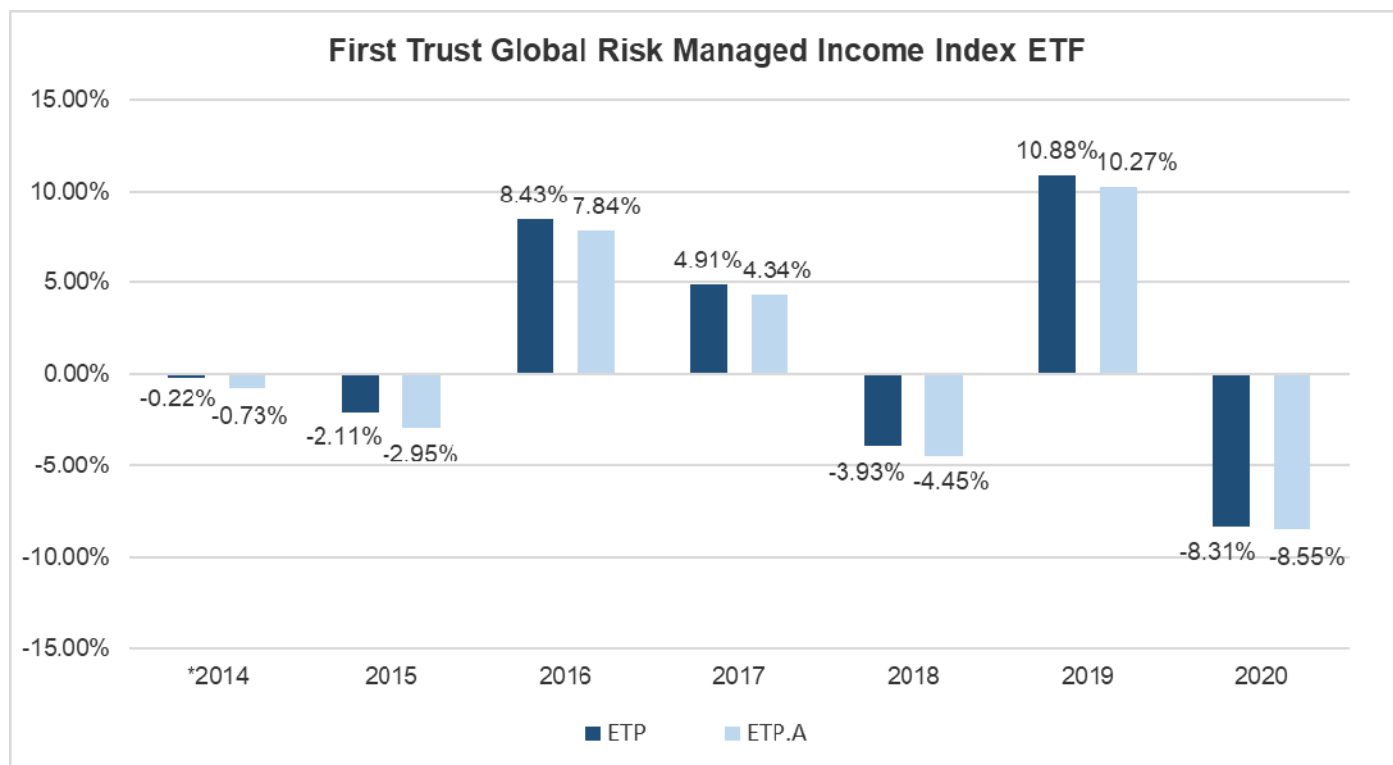
**Past Performance**
